Session 5 - Public Debt and Women's Right: From A Feminist Perspective and Praxis | FES-AU

While IMF debt relief programs can provide significant benefits by reducing overall debt burdens and potentially freeing up resources for social spending, however, the associated austerity measures and conditionalities can adversely affect women. The impact largely depends on how governments implement these programs and whether they prioritize protecting and enhancing social services that support women and address gender inequalities. Applying a feminist perspective to debt discussions is crucial for understanding both the macroeconomic and microeconomic dimensions of gender inequalities, which are influenced and perpetuated by historical, social, and political processes. Feminist economists have long critiqued the detachment of economic policies from their complex social contexts. Debt contracts are typically viewed as impersonal, rational agreements between self-interested parties. However, this perspective overlooks the historical, social, political, and economic contexts that shape these contracts and the distributive choices they entail among different social groups.

Session 10 - Combating Predatory Lending and Promoting Austerity-Free Debt Restructuring in Africa | Afronomicslaw/AfSDJN

The African borrowing landscape has witnessed a marked increase in private creditor involvement in recent years. This shift has brought concerns about predatory lending practices to the forefront. Such practices often involve high interest rates and unfavourable terms, trapping countries in cycles of debt that are difficult to escape. Concurrently, many African countries, burdened by high debt levels, are often subjected to austerity measures as part of debt restructuring processes. Typically, these measures involve substantial cuts in public spending, adversely affecting social services and impeding economic growth. This session presents the work done by early-career legal researchers engaging in analytical and critical discussion on predatory lending and austerity-free debt restructuring in Africa.

Session 13 - Rethinking Sovereign Debt Through a Human Rights Lens: Lessons from Mozambique Center for Democracy and Human Rights (CDD)

Debt has traditionally been seen as a public finance issue. Missing from the mainstream approaches on public debt is its impacts on the country's population. This section discusses the link between public debt and human rights, focusing on the impact of debt on the realization of economic, social, and cultural rights and the rights to development. Session 15 - Campaigns & Movement Building for Debt Advocacy: Engaging citizens for Sustainable Change Through a Feminist Lens | Okoa Uchumi
