

When it comes to debt vs. Development issues, AFRODAD's Chairman Mr. Opa, is a guru


Africa's current macroeconomic performance shows that many countries have accumulated new debts and they are facing debt repayment problems which are putting them at a risk of debt distress. Worst still, some of those are already considering seeking refinancing. While different countries in Africa may be experiencing the same based on their own realities, the emerging pattern points to the need for discussion on short, medium to long-term solutions required to deal and avert such crisis.



It is for this reason that AFRODAD, in partnership with SAIPAR hosted a validation workshop to enrich the draft of the Revised African Borrowing Charter 2018. Discussions and input of various experts contributed to finalizing the latter. The workshop report can be found at http://afrodad.org/index.php/center-of-excellence/articles-position-vews/debt-management. At this stage the Charter is available in English, French and Portuguese.

Main aims of the Charter are to:

Ensuring that the contraction and management of public debt, including the issuance of public guarantees, selection and implementation of debt financed projects and formulation and execution of overall fiscal policy takes place within the context of a strengthened legal framework and rule of law.







SPRING MEETINGS

AFRODAD attended and indeed participated in Spring meetings organized by the International Monetary Funds and the World Bank. The Spring Meetings of the Boards of Governors of the International Monetary Fund (IMF) and the World Bank Group (WBG) bring together central bankers, ministers of finance and development, parliamentarians, private sector executives, representatives from civil society organizations and academics to discuss issues of global concern, including the world economic outlook, poverty eradication, economic development, and aid effectiveness. Most of these correlate with AFRODAD's agenda.

We have been told that "a few decades (50 years) ago, Korea was grappling with poor infrastructure, unemployment, a per capita income of less than \$350 a year, and a dependence on foreign aid. But in just few decades Korea has the world's 11th biggest economy". national level, and as refugees at the regional or international level...on the account of conflict and instability situations. every case is much more than a personal tragedy, as it threatens to undermine the achievement of Africa's broader development objectives and the sustainable development goals. that's why it's important to discuss and develop a common position on this issue and propose solutions to forced migration in the region. AFRODAD, through its know-how on policy matters, added value to the discussions and recommendations that APC intends to take forward for implementation by national governments.

AFRODAD was part of the first East African Governance for Health Convening, Nairobi, Kenya

The purposes of this convening were to reflect on how the above global trends in governance for health are playing out in the region, and in particular how existing governance challenges are exacerbated by the impact of powerful private and economic interests, promoting marketization and commercialization of health, often reinforced by donors which increasingly promote their economic self-interest through their development assistance for health;

To identify concrete examples of those trends in the region and explore the players involved in promoting them, who benefits from them, and the impact on health rights; and to reflect on strategies of response; how civil society can act together to expose and challenge such harmful influence on the realization of health as a human right and public good. This will include considering strategies to safeguard the effective use of public resources for health rights, in the face of commercialization and marketization.

The meeting established the platform on which AFRODAD will be part of the Africa CSO's advocacy group working on PPP's and Privatisation.
